### ASBA provides overview and analysis of state report on classroom spending

The office of the Arizona Auditor General released its annual report on classroom spending on Friday. Eroding state funding for K-12 education has left a smaller percentage of dollars available for Arizona school districts to dedicate to teachers (including teachers aides and substitutes), general instructional supplies like paper and pencils, instructional aides like textbooks and instructional software, and activities like choir, band and field trips. Despite this, the majority of dollars, including classroom dollars and those for student support and instructional support continue, to be dedicated to improving and supporting student learning. # FY 2014 costs of implementing Common Core estimated at \$156.6 million statewide

In late January, ASBA and the Arizona Association of School Business Officials conducted a survey of Arizona school districts on costs of implementing Arizona's Common Core Standards. Districts from urban, suburban and rural Arizona school districts statewide, representing 339,264 students or 38 percent of the total K-12 district population, responded. Statewide estimates were extrapolated from this information.

Based on the survey results, ASBA and AASBO estimate statewide costs for essential elements of Common Core implementation for fiscal year 2014 (the 2013-2014 school year) to be \$156.6 million. This estimate is comparable to the estimate released in January by the Arizona Department of Education.

<u>View a summary of the results</u>, including breakdowns of costs for training, curriculum materials and textbooks, and district-level assessments. An estimate for future costs related to technology, including administration of the PARCC assessment, is included as well.

# ADE, Governor's Office surveying teachers statewide on Common Core

The Arizona Department of Education and the Governor's Office of Education Innovation have emailed an extensive survey to teachers statewide aimed at gauging their perceptions of Arizona's Common Core Standards, their understanding of the standards, and whether they believe they are receiving adequate training and support on implementation of the standards within their schools and districts. The survey closes on March 22. According to ADE, the purpose of the survey is "to identify how educators may be best supported during the transition to Arizona's Common Core Standards."

### Three K-12 Arizona schools receive gold awards from Beat The Odds Institute

James W. Rice Elementary School and Metro Tech High School in Phoenix and Estes Elementary in Marana were the only schools to attain gold medal status, the highest level of achievement in this program. Demonstrated, consistent growth in student academic achievement in math and reading over two or more consecutive years among other criteria is required to win and be conferred with the title of a Beat the Odds School. Fifteen Arizona schools earned silver and bronze awards.

Beat the Odds, an initiative of the Center for the Future of Arizona, is an intense multi-year school improvement program which provides training and mentoring for principals. The Beat the Odds program is based on methodology from best-selling author Jim Collins and focuses on minority-intensive, low income student populations.
